I, William G. Anderson, Registered Land Surveyor, hereby certify that:

I have surveyed, divided and mapped that part of Government Lots 5 and 6, Section 16, Township 49 North, Range 14 West, City of Superior, Douglas County, Wisconsin, described as follows:

Commencing at the South Quarter Corner of said Section 16; thence North 89 degrees 22 minutes 38 seconds West, along the south line of the Southwest Quarter of said Section 16, a distance of 829.87 feet to the southerly projection of the west line of the Plat of Paine's Addition; thence North 00 degrees 29 minutes 47 seconds East, along said line and it's northerly projection, a distance of 1200.00 feet; thence North 89 degrees 22 minutes 38 seconds West, parallel with the south line of the Southwest Quarter of Section 16, a distance of 548.18 feet; thence North 00 degrees 29 minutes 47 seconds East a distance of 64.49 feet to the Point of Beginning; thence North 79 degrees 38 minutes 22 seconds West a distance of 150.00 feet; thence North 10 degrees 21 minutes 38 seconds East a distance of 90.00 feet; thence South 79 degrees 38 minutes 22 seconds East a distance of 150.00 feet; thence South 10 degrees 21 minutes 38 seconds West a distance of 90.00 feet to the Point of Beginning.

Together with a 30 foot wide easement for driveway purposes as shown on the face of this map. The easement begins at the north end of the New York Avenue cul-de-sac and ends at the east line of Lot 1 of this C.S.M.

Subject to and together with all valid easements, restrictions and reservations, if any.

I have surveyed, divided and mapped the land described under the direction of the Fred and Nancy Paine, owners.

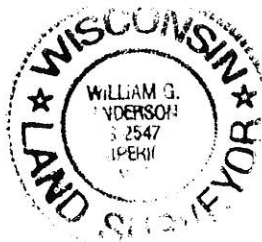
This map is a correct representation of all exterior boundaries of the land surveyed and the division of that land.


